#### **President's Report**

President Jay Frye spoke of several reasons for the co-op's continued success, focusing on financial stability and a dedicated staff. He proudly told members "we are consistently among the leaders of Illinois' co-ops in paying out these credits, having returned more than \$9.1 million in the co-op's 80-year history." You can read more about capital credits on our website.

Jay was also proud to report that on the most recent American Customer Satisfaction Index (ACSI) survey, we earned a score of 85, our highest yet, which is 10 points higher than the average for municipal and investor-owned utilities. We scored highest in three areas: knowledgeable employees, excellent customer service, and prompt response to outages. We always carefully review the survey and value the feedback we receive from you, on what we are doing well and where we can improve.

#### **General Manager's Report**

After telling a little about herself, General Manager Alisha Anker told members, "My basic philosophy about staying competitive in the electric utility industry is achieved by managing the three Rs – Rates, Risks and Reliability - tweaking one will certainly impact the other two."

She said one of her roles at Prairie Power was to secure contracts for Prairie Power's power portfolio. Our wholesale power costs from Prairie Power made up 65 percent of every dollar spent last year. Alisha told members that with her intimate knowledge of that portfolio, "I have confidence we at Menard can move a larger share of your dollar to operations, maintenance and member services here at home, and better yet, to operating margins that are returned to you as capital credits." Alisha also highlighted achievements by the co-op last year that have improved the electrical system and increased service reliability. She noted substation upgrades to ensure adequate capacity, reliable voltage levels, and continued system reliability, as well as IT and cyber security service improvements.

Alisha also gave details about the co-op's centralized Supervisory Control and Data Acquisition (SCADA) system that gives the co-op real-time information from the field that is essential for reliable operations.

In closing, Anker remarked, "This industry is about improving quality of life. I look forward to working on your behalf to enhance existing programs and develop new ones that will improve the quality of your lives."



Our Board of Directors is made up of nine members elected from and by you, our members, to serve three-year terms. Directors Warren Goetsch of District 8, Mike Patrick of District 7 and Jodine Tate of District 3 ran unopposed and were re-elected.

Just after the meeting, the Board reorganized and Jodine Tate stepped down as Treasurer; Dennis Ryan was elected to the position.

to \$44,199,678 last year. Co-op meets requirements of RUS, FFB, NRUCFC & CoBank.



### Incentives

\$100 – Electric Water Heaters \$200 – Air-Source Heat Pumps \$300 – Geothermal Heat Pumps

Incentives are available one time per service location to the member who initially installs the unit. Heat pumps must be part of a wholehouse heating/cooling system. Water heaters must be 40 gallons and enrolled in our load management program. Additional restrictions apply – see our website or contact our office for details.





In the heat of August, the sun's rays certainly feel powerful, and it isn't hard to imagine how those rays can be used to generate electricity.

You can purchase solar-generated electricity through the Bright Options Solar program from our wholesale power provider, Prairie Power, Inc. (PPI). All without the risks, hassles or costs of having solar panels at your home.

The program offers blocks of solar energy generated from two 500kw Illinois solar farms operated by PPI subsidiaries. The Shelby Solar Farm is in Shelbyville and the Spoon River Solar Farm is near Astoria.

#### How does it work?

You choose one of three block options to purchase:

#### 200 kwh - \$12/month 400 kwh - \$24/month 600 kwh - \$36/month

The cost is added to your monthly electric bill in addition to all other normally billed charges.
