

2018 Annual Meeting

We want to thank the more than 370 registered members and their families (nearly 750 people in all!) who joined us on the hot and breezy afternoon of June 14 for our Annual Meeting of Members.

For those of you who were not able to make it, we offer this brief synopsis of the topics discussed.

This year's theme was Innovation Through Collaboration. Board President Jay Frye and General Manager Alisha Anker changed things a bit this year by collaborating on a joint presentation to members.

Frye stated that "the co-op's ability to innovate, or modernize, the electric system and its operations is key to its future." He and Anker discussed infrastructure improvements that included upgrading 25 miles of line, upgrades to breakers at several substations, and irrigation improve-

ments including the popular new load control program involving a mobile technology control application that allows us to communicate with irrigation pivots.

Frye and Anker also discussed how modernizing the co-op's net metering policy allows members with renewable energy such as solar to net meter up to 10 kw under a more efficient banking methodology and a new net billing policy that allows for larger installations. Twenty-four member-owned solar systems are

currently connected, and Anker stated that she expects more interest and growth as state incentive programs are implemented. See our website's renewable energy page for details.

Anker discussed the co-op's new outage management and communication system that allows our information database, system configuration maps and meter reading tools to collaborate. "The application not only runs a prediction engine to quickly pin point the location

of trouble on the system, but my favorite feature is that it communicates this information in real-time to the members, who can in return communicate their outage to us," said Anker, referencing the MyMEC mobile app.

Treasurer Dennis Ryan reported the financial statement from the Official Notice. He highlighted our recent return of \$470,000 in capital credits, which brings our total return of capital credits to members to over

\$10 million. He also highlighted that our members owned 40 percent of total assets at the end of 2017, totaling \$1,923,390; \$1,141,366 of which are capital credits allocated from Prairie Power, Inc. and \$192,551 allocated from CoBank and other financial resources; those credits will be returned to us at a later date. Our co-op is governed by nine directors elected by and from you, our

members, to serve three-year terms. This year Gary L Martin, District 2; D. Jay Frye, District 5; and Donald E. (Chuck) McMillan, District 9 ran unopposed and were re-elected.

Members also voted to approve a bylaw change to director qualifications stating a director must have an active service that includes a facility charge and must have their primary residence within the geographical boundaries of the district served.

Serving our members

Several of our employees volunteered their time this summer to light up the Mason County Fairground’s equestrian ring. The project was funded by a 2017 Sharing Success grant sponsored by CoBank, a Menard Electric lender. The installation was completed with assistance from our engineering and operations department personnel. Crews installed underground primary lines, secondary facilities and poles where the lighting fixtures are mounted. All equipment was purchased by the fair board with monies from the grant.

A few employees also hosted an electrical safety station at the 4-H Farm Safety Day Camp at the fairgrounds on Friday, June 15. The station was one of eight sponsored at the Day Camp. Over 100 campers learned how to stay safe around electricity and utility facilities near their homes and farms. They also learned about the job of a lineman and were able to get hands-on with the gear used (the kids decided those tool belts really are heavy!). Menard Electric also sponsored the Live Line Demo as the Day Camp’s finale presentation. The demo produced lots of sparks and some loud booms, but the showmanship was in the spirit of teaching the campers how they too can live another day by being safe around electricity.

“These are just two examples of our employees living out the co-op’s founding principle of Commitment to

Community,” says General Manager Alisha Anker. “As a co-op family, we were happy to be of service.”



Youth to Washington Tour
