Petitions ready now — Due May 1

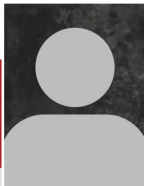
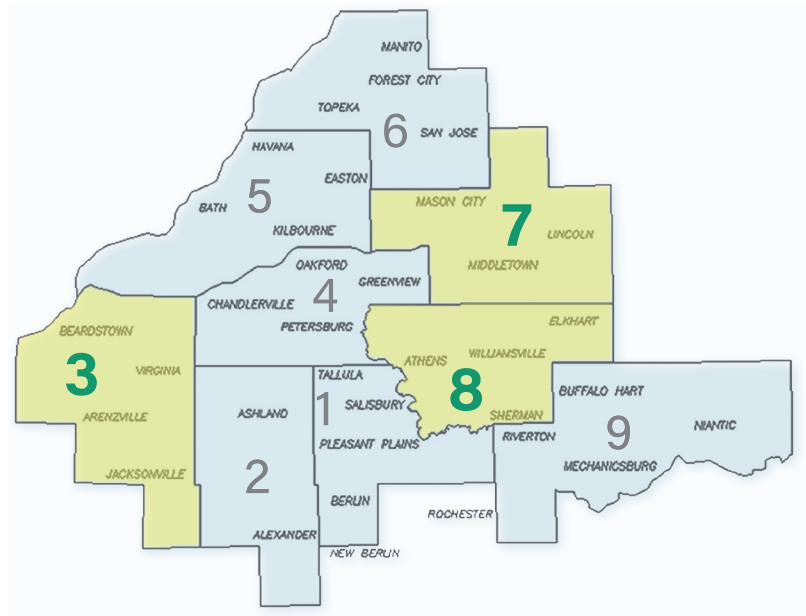


The Director Election will be held at this year’s Annual Meeting June 17, 2026, at Pleasant Plains High School.

Our Board of Directors is made up of nine directors, each representing a Director District and serving a three-year term. Three Director Districts are up for election at each Annual Meeting of Members. At the 2026 Annual Meeting that includes Districts 3, 7 and 8.

The petition will need to be signed by at least 10 active Menard Electric Cooperative members and returned to our office by 4:30 p.m. on Friday, May 1, 2026.

Farm and home spring planting season tips

Farm

- Review safety with all your farm hands now before the season gets busy.
- Keep a 10-foot minimum distance between equipment and lines. That is below, to the side, and above all electrical lines and equipment.
- Keep an eye on lines in the air and the guy wires beside poles. Use a spotter to verify clearance.
- Field cultivators, sprayer booms and even tractor antennas can be higher than 10 feet. Avoid raising arms of planters, cultivators or truck beds near lines. Inspect the entrances to fields to ensure there is adequate clearance for equipment under lines and near poles.
- If your vehicle or machinery were to come into contact with a power line, do not get out; stay put and call 9-1-1 to dispatch the appropriate utility to deenergize power.

Home

- It's all about location! Plan carefully before planting around your home and property and call 8-1-1 before digging.
- We recommend not planting any shrubs or trees within 15 feet of overhead lines. Also consider the size of the

tree when fully grown; you want the outer edge of the branches (not the trunk) to be at least 15 feet from single-phase power lines and 25 feet from three-phase power lines.

- And don't forget to consider underground utilities that can be affected by root growth; trees and shrubs should be planted at least 10 feet from padmounted transformers and meters.
- One more note: Even small plants and vines can interfere with electrical equipment and prevent linemen from accessing areas to perform maintenance. A best bet is to keep all plantings away from poles, meters and padmounted transformers.
- You can also consider energy efficiency — The U.S. Dept of Energy says planting in the right place could save you on heating and cooling costs by blocking summer sun and winter winds. They suggest planting deciduous trees with high leaves and branches on the south side of the home, and to consider creating afternoon shade for your air conditioner. Evergreens or shrubs planted on the north/northwest side of the home could make a winter windbreak, but evergreens on the south side could block the warmth of the winter sun from warming the home.

ENERGY EFFICIENCY TIP OF THE MONTH

As we prepare for the seasonal shift, remember to set your ceiling fan rotation accordingly. In winter months (or whenever your home heating system is running), fan blades should rotate clockwise, which produces an updraft that pushes warm air down. In summer months (or whenever your home cooling system is running), blades should rotate counterclockwise, which produces a downdraft or windchill effect that makes you feel cooler. When used correctly, ceiling fans can boost comfort and allow you to adjust the thermostat a few degrees for energy savings.
