



## **Storm restoration**

We want to say thank you for the outpouring of support we received from our members during the storm that hit March 31, 2023. Our line crews appreciated all the kind words and messages we received. Here's a little information about what happened to our system

during that destructive night.

Just shortly after 5:30 p.m. the high winds, rain, hail and tornadic activity entered our service territory. The storm traveled at speeds as strong as 80 mph as it cut through our area. Outages came right away from Topeka, Virginia, Ashland, Tallula and Petersburg. At 5:50 p.m. we lost Ameren-owned transmission to our substations in Petersburg and Virginia for 14 minutes. Shortly thereafter Prairie Power Inc. (PPI)-owned transmission was lost to our Barclay and Lanesville substations until 7:57 p.m. Meanwhile our line crews progressed through our territory rebuilding portions of our line and restoring individual outages, working all through the night.

The north edge of Sherman at I-55 and Sudduth Road was hard hit by a tornado, and our members in that area were unable to have power restored that night. Three Ameren steel lattice transmission towers were twisted into piles, PPI's wooden transmission poles were snapped, and our underbuilt lines on those poles collapsed. This area was a tangle of metal, conductors and debris. All the utilities and contractors worked to rebuild the transmission system and our underbuilt line. Most members were restored Monday at 4 a.m. and the remaining few dozen at 6 p.m. that evening.

### 3 electrical safety tips



## Automatic Payment

### **Budget**Wise

**Budget Billing:** This sets a specific payment amount based on the past 12 months' usage to be paid each month of the cycle. On the once yearly true-up month (June or November) a credit or additional amount due is applied based on actual electric usage for the cycle.
